

Volunteer Disclosure Statement Classification Guidelines

If convicted of any of the following, applicants are automatically disqualified from any coaching opportunity for the current season:

- Any sort of abuse
- Any sort of assault/battery
- Physical or sexual rape
- Any crime of sexual nature
- Homicide or Manslaughter
- Attempted Murder
- Domestic Violence
- Child neglect
- Felony drug crimes
- Animal cruelty
- Theft Robbery
- Forgery/fraud
- Kidnapping
- Arson
- Weapons violations
- Any crime (misdemeanor or felony) involving children as an accomplice or victim

If convicted of any of the following within the specifications stated, applicants are automatically disqualified from any coaching opportunity for the current season:

- *Drug/Narcotics violation- one conviction within the last ten years
- Driving under the influence- two convictions, or one conviction within the last five years
- Public Drunkenness- two convictions, or one conviction within the last five years
- Disorderly Conduct- two convictions within the last five years

**Two misdemeanors within the previous five years will result in automatic disqualification.*

The following convictions could possibly result in disqualification, and will be reviewed by the Greer Recreation Department and/or sport specific board:

- Crime against a person
- Falsification of Information

**Any disqualification will be reported to the applying coach, and may be appealed to Recreation Department Director only.*
